About Nature Foundation

Nature Foundation is an apolitical notfor-profit foundation that invests in conserving, restoring and protecting South Australian landscapes, flora and fauna to ensure their survival.

We invest in a broad portfolio of activities including:

- Increasing the area protected for nature conservation
- · Education and citizen science
- Creating enduring partnerships
- Multidisciplinary conservation management
- Scientific research
- Raising funds for nature conservation

Nature Foundation has extensive experience in managing land for conservation and owns and manages eight nature reserves totalling over 500,000 hectares:

- Witchelina: a diverse arid land reserve between Marree and Lake Torrens
- Hiltaba: adjacent to the Gawler Ranges National Park protecting Yellow-footed Rock-wallaby habitat
- <u>Para Woodlands</u>: former farm near Gawler being restored to a grassy woodland
- <u>Tiliqua</u>: protecting threatened Pygmy Bluetongue Lizard habitat near Burra
- Watchalunga: a wetland near Finniss protecting Southern Emu-wrens and native fish
- Murbpook Lagoon: wetland near Blanchetown which with its surrounds protects 19 threatened species including Regent Parrots
- Geegeela: protecting buloke, an important food source for Southeastern Red-tailed Black-cockatoos
- <u>Bullock Bridge</u>: a haven for birds and native fauna on the Limestone Coast

About the Forever Nature Fund

Our goal is to raise \$20 million by 2030 to double our impact to 1 million hectares of land protected for critical habitat for threatened species.

The Forever Nature Fund has been created for the purpose of raising capital to purchase and manage areas of critical habitat, that are prioritised using data driven scientific and environmental assessment tools. The Forever Nature Fund will enable Nature Foundation's team to act quickly and decisively when a property of high conservation value is available for purchase.

Our Vision

Nature Foundation was founded over 40 years ago with the simple mission to conserve, protect and restore Australian landscapes for future generations. We privately manage nature reserves and currently provide over 500,000-hectares of critical refuges for Australian flora and fauna.

To realise a nature-positive future where biodiversity is secure and our life-support system is thriving forever, Nature Foundation aims to purchase more land with high biodiversity value to create more critical refuges for Australian wildlife.

We have set an ambitious target to double our impact to 1 million hectares by 2030—in support of Australia's commitment to 30 per cent of land and sea protected by 2030.



The Problem

Habitat loss and land clearing has caused the extinction of 62 Australian terrestrial species. Between 2000 and 2017 over 7.7 million hectares of land habitat was cleared in Australia (Source: DCCEEW 2021 Australia State of the Environment Report).

The compounding impacts of climate change will cause a further decline in Australia's biodiversity, with increasing numbers of species and ecological communities being listed as threatened across the country.

Nature and its life-support system is critical for human survival providing food, water, climate regulation and well-being for all society.

The Solution

Conserving areas of high biodiversity value expands the network of protected land supporting Australian wildlife and provides vital refuges for threatened species and ecosystems. Effective protected land management has positive outcomes for biodiversity.

Investing in protected and conserved areas is investing in our future and in the health and wellbeing of future generations. We ask you to consider leaving a Gift in Will directed towards the Forever Nature Fund and help protect habitat and wildlife, today, tomorrow and forever.

Investments will be excluded that conflict with the organisation's purpose and values, including Environmental, Social and Governance principles.
