**We ask that visitors to Witchelina are self-sufficient. Witchelina Homestead does not sell food supplies or fuel, and water is limited so please bring your own water supply if camping. If staying at the Shearers' Quarters, Overseer's House or Old Mt Nor West Homestead we ask that you limit your shower time to 3 minutes.**

**On arrival at Witchelina, please check in at the Homestead. When setting out on the marked walking trails, we suggest you register your departure and return in the visitor box provided. When setting out on a Nature Drive please inform the resident Manager and for your safety we recommend you carry a communication device, adequate water, food, fuel, tyres and tools.**

Please note there is limited wheelchair access.

**CONDITIONS OF ENTRY:** Visitation is at your own risk. To minimise your impacts on the environment and help protect Witchelina Nature Reserve please follow these rules:

- Follow directions from Nature Foundation SA staff.
- Keep wildlife wild, do not feed or disturb animals.
- Please do not fossick, damage, remove or disturb vegetation, geological, cultural and heritage sites (plants, animals, rocks and artefacts are all protected).
- Camping is only permitted in designated camping areas and campfires are permitted in the campgrounds in the fire rings provided and campers are encouraged to bring their own firewood. Do not collect dead wood as it is a valuable habitat.
- Smoking is not permitted in any building.
- Keep to defined vehicle tracks and walking trails.
- Be considerate of other users.
- No pets are allowed (NOTE: baiting is present).
- Please take your rubbish with you where possible.
- Leave gates as you found them.
- Normal road rules apply on the Nature Reserve.
- Drive at a walking pace around buildings and campsites. There is a 40km/hr speed limit on Reserve tracks and no motorbikes are allowed.
- No firearms, shooting or trapping are allowed.
- You are the person primarily responsible for your safety and for the safety of any children.
- Except by arrangement with Nature Foundation SA, accommodation and/or access to Witchelina Nature Reserve is closed during summer months (15 November–15 March). At other times the Nature Reserve may be closed due to management-related activities, or circumstances outside Nature Foundation's control, including weather extremes, fire danger or other emergency situations where we may be required to take action without notice.

**TERMS AND CONDITIONS FOR ACCOMMODATION BOOKINGS:**

- Booking requests are not guaranteed until Nature Foundation SA staff confirm your booking via email.
- Full payment is required when your booking is confirmed.
- For bookings of 10 or more people a non-refundable deposit of \$100.00 is required to secure the booking. Full payment will be required on the outstanding balance 7 days prior to arrival or the booking will be cancelled.
- Check in is between 11am and 4pm on the day of arrival.
- Check out is by 10am on the day of departure unless otherwise negotiated.
- Guests must ensure that all facilities are clean and returned to their original state before departure.
- Additional charges may be made if accommodation is damaged or left in an unsatisfactory condition or where breakages, theft and loss to or from the property or its contents occurs.
- Nature Foundation SA reserves the right to refuse, cancel or terminate a booking and the right to ask guests to leave who do not adhere to our Conditions of Entry and Terms and Conditions for Accommodation Bookings.
- Fees and Charges may be subject to change without notice.
- Nature Foundation SA takes no responsibility for your vehicles or personal property during your stay.

**Cancellations:**

An administration fee of \$25.00 will be charged for all booking cancellations where the booking is cancelled greater than and equal to 21 days' prior to the date of planned arrival. Refunds, minus the administration fee, will be paid within 30 days of the cancellation. It is up to the payer to provide their bank details to Nature Foundation SA. Bookings cancelled within 21 days of the date of arrival incur a cancellation charge of 100% of the fees paid subject to the variation clause below.

**Variations:**

Variations can be agreed to with prior written arrangement.

Where there are extenuating or unforeseen circumstances from either party (eg severe medical episode, fire conditions) Nature Foundation SA's CEO at their discretion may authorise a refund or a suspension of the payment as a "credit" to re book within a 12-month period from the original proposed date of arrival. After the 12-month period has expired, and if the travel has not occurred, 100% of the original payment made is retained by Nature Foundation SA and the "credit" cancelled.
