**We ask that visitors to Witchelina are self-sufficient. Witchelina doesn't sell food supplies or fuel, and water is limited so please bring your own water supply if camping. If staying at the Shearers' Quarters or Manager's House we ask that you limit your shower time to 3 minutes.**

Please help protect Witchelina Nature Reserve and enhance your experience, by following these guidelines:

- Do not damage or remove any native plants (or dead wood)
- Keep wildlife wild. Do not feed or disturb animals
- Respect geological, cultural and heritage sites
- Conserve native habitat by using gas stoves
- Observe fire restrictions (usually 1 November to 31 March)
- Keep to defined vehicle tracks and walking trails
- Be considerate of other users
- Leave your pets at home (Note: 1080 dog baiting underway)
- Take all your rubbish with you
- Dig no latrines – use existing toilets only
- Follow directions from NFSA staff.
